

Dear All,

This communication is to clarify PI Exception process when Kuali Research goes live on January 21, 2020.

What's staying the same: KR will continue to apply PI's title code to determine PI eligibility.

What's changing: PI Eligible title codes will not route to the Department Chair, while non-eligible and conditional title codes will route to the Chair for approval.

- 1. Members of the Academic Senate**
Professor - all ranks; Professor in Residence - all ranks; Professor of Clinical X - all ranks but instructor; Research Professor; Professor Emeritus - all ranks; Senior Lecturer and Lecturer with Security of Employment; Acting Professor and Acting Associate Professor (but not Acting Assistant Professor); University Librarian (but not other librarians); Registrar and Chief Admissions Officer; Vice Chancellor; Chancellor
- 2. Salaried appointees in the Adjunct Professor series, with the exception of the Instructor rank.**
For School of Medicine applicants, a >50% salaried appointment is required for Adjunct Professors to qualify for automatic PI eligibility. Salaried appointments <50% require a PI Exception approval.
Note: The source of salary support may be state, extramural or other departmental funds.
- 3. Appointees salaried at 50% or more of full time in the Clinical Professor series, with the exception of the Instructor rank.**
Note: The source of salary support may be state, extramural or other departmental funds.
- 4. Appointees in the Research Scientist/Scholar series.**
At SIO, a review is required to increase the percentage of appointment of Research Scientists because of the commitment of institutional resources to Research Scientists.
- 5. Assistant, Associate and full Project Scientists/Scholars may serve as Co-PI with professorial and research scientist appointees.**

If a PI Exception is required, the following will need to be uploaded into Kuali Research Record prior to routing for departmental review and submission.

- 3. CV and Bio Bibliography**

Conditional eligibility statement;

For PI Exception's with Title Codes conditionally eligible the KR system will trigger routing for critical criteria and will be routed for departmental approval. After determination that a PI Exceptions is NOT required based on the criteria being met
