HS SPPO Spotlight



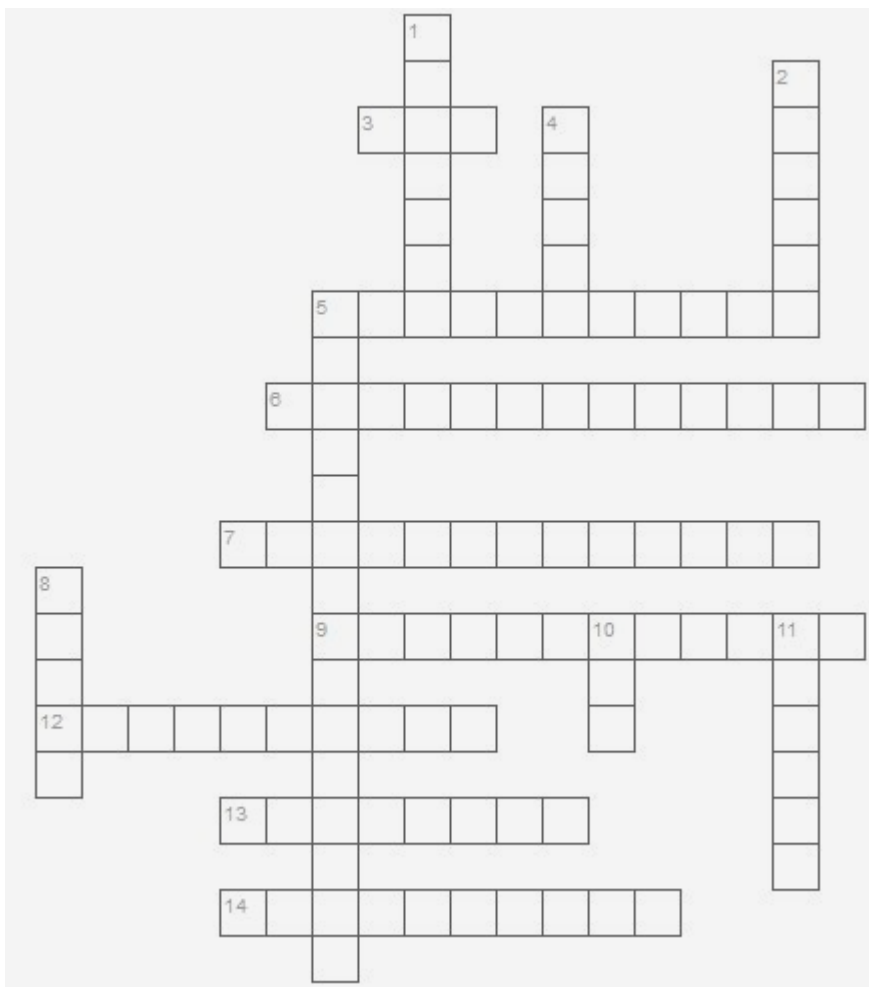
